

RESOLUTION NO. 2026- 08

**A RESOLUTION OF THE CITY COUNCIL FOR
THE CITY OF FAIRFIELD BAY, ARKANSAS,
AMENDING THE BUDGET
FOR FISCAL YEAR ENDING
DECEMBER 31, 2026;
APPROPRIATING FUNDS;
AND FOR OTHER PURPOSES**

WHEREAS, The City Council has had on-going review of the City's anticipated expenditures during the current fiscal year, including compliance with the City's 2026 Budget Ordinances (as amended from time to time); and

WHEREAS, The City delivered a check in the 2024 calendar year, and the vendor failed to deposit the check and now asks for the City to re-issue the check; and

WHEREAS, the funds at issue were previously appropriated for the year ending December 31, 2024, but need to be appropriated for the current calendar year as well;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF FAIRFIELD BAY, ARKANSAS:

1. The City Council finds and determines that the Recorder-Treasurer timely issued and delivered check number 07454, for \$1,000.00, on November 26, 2024, to the vendor; and further that the vendor received the check but failed to deposit it timely and now asks for the City to re-issue the check.


2. The Mayor, and the Recorder-Treasurer, be, and they are hereby, **AUTHORIZED AND APPROVED** to issue a separate check to the same vendor (Municipal League) in the current calendar year. The fiscal impact to the City is negligible, but the funds have not yet been appropriated for the current calendar year ending December 31, 2026.

3. The City Council hereby **APPROPRIATES AND APPROVES** additional expenditures not to exceed \$1,000.00 for this expense in the Police Department Budget, which funds may be taken from unappropriated general funds, or from unappropriated Franchise Tax income for the calendar year ending December 31, 2026. An amendment to the 2026 Budget Ordinances will be made separately, in accordance with the City's usual practice of amending the Budget by Ordinance at the end of the calendar year.

4. The Mayor, the Recorder-Treasurer, and the Police Department, be, and they are hereby, **AUTHORIZED TO TAKE** any and all appropriate actions necessary to put this Resolution into effect, in accordance with this Resolution, for the calendar year ending December 31, 2026.


5. This authorization, and appropriation, is effective immediately following its approval by the City Council, and the expenditures may take place as the Recorder-Treasurer shall decide. Posting and publication in the newspaper will take place according to the Recorder-Treasurer's normal schedule.
