RESOLUTION NO. 2022-34

A RESOLUTION OF THE CITY OF FAIRFIELD BAY
CONCERNING LINENS FOR
THE CONFERENCE CENTER FOR
THE CITY OF FAIRFIELD BAY;
APPROPRIATING FUNDS, ACCORDINGLY;
AND FOR OTHER PURPOSES

WHEREAS, The City of Fairfield Bay has recently received estimates for certain linens at the Conference Center; and

WHEREAS, the City has received and reviewed the estimate, and has selected the estimate provided by Efavormart, in the amount of \$3,921.76, for the purpose of purchasing certain linens for the Conference Center, after review by the City Council;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAIRFIELD BAY, ARKANSAS:

1. The City Council has reviewed the August 2, 2022, Quote to purchase linens, from Efavormart, in the amount of \$3,921.76, a total amount less than \$35,000.00.
2. The City Council hereby APPROVES the Efavormart quote for the linens in the amount of \$3,921.76, after discussion, at the City Council Work Session.
3. The City Council hereby APPROPRIATES FUNDS, from unobligated funds in the City's General Revenue account, for the purpose of paying for the linens, at the Conference Center, to pay Efavormart in the total amount of \$3,921.76.
4. The City Council authorizes the Mayor to purchase the linens for the Conference Center, accordingly.
5. The Mayor, and the Recorder-Treasurer, are hereby authorized to take any and all steps necessary to put this Resolution into full force and effect, immediately from and after its passage.
6. An amendment to the 2022 Budget Ordinance may be made, separately, in accordance with the City's usual practice of amending the Budget by Ordinance after the close of the calendar year.

IT IS SO RESOLVED AND APPROVED by the City Council for the City of Fairfield Bay, Arkansas, at its regular meeting on this 8th day of August, 2022.
